6. Stationery .Handlings charges data collection and camp charges
7. Charges of investigation (indoor pathology investigation will get 50 percent concession)
8. The facility of protocol writing will be provided as per the requirement with separate charges as well medicines will be provided with all preclinical authorised documents
9. after approval of budget first ethic committee charges or total 25 percent of funding will be released from company to begin the trial
10. after confirmation of completion of all targetted sample size the second 50percent instalment should be released from company
11. the final payment instalment of 25 percent will be released and the report of trial or as per demand in MOU signing the all CRF s will be handed over to company
12. the report of trial will be maintained with both parties

Research Policy For clinical Trial

1. The teachers who will get the clinical trial can be a PI (principle investigator)
2. The MOU should be signed between company and college principal

The PI , CO PI, Physician and company representative will form a team and discuss protocol to finalize

The final amount of PI and COPI will be disbursed by college in following way

1. In the case of clinical trials IN WHICH SEThe Pi will get 30 per cent amount of entire trial budget irrespective of duration
2. The co PI will get 20 percent amount of total budget of trial irrespective of duration
3. The budget of trial means the amount except the diagnostic tests, and statistical charges and ethic committee charges
4. PI and CO-PI of the funded trial will get the amount which is sanctioned by funders if they are mentioned in the budget
